Grammar—Compound Sentences

A compound sentence is formed by joining two main clauses with a connective.

For example, I like bananas and I like grapes. Ms Soulsby can be a bit strict but she is a nice lady.

In Year 1, children start to create compound sentences by using connectives such as and, but.

From Year 3 onwards, children should regularly be using compound sentences, and begin to use more complex sentences (which we'll cover next week)

Good connectives to start to use: and, but, so, or, as well as, because, then

Help your child use compound sentences when completing home learning tasks. Encourage them to speak in compound sentences.

Dear Parent

PARENT GOVERNOR ELECTION

I am writing to advise you that there is a vacancy for a parent governor on our school's governing body and I therefore invite nominations to fill the vacancy.

Parent governors play an important role as members of the Governing Body, which is responsible for directing the conduct of the school and for promoting high standards of educational achievement. The term of office for parent governors as determined by the Governing Body is 4 years. The role of the Governing Body is to provide strategic management of the school, overseeing the school's budget and to act as a "critical friend", supporting the work of the Head teacher and the school staff. The Full Governing Body is responsible for monitoring the school's progress and in setting annual targets for the school's performance and for the Head teacher (and ensuring that the Head teacher sets targets for other staff). Our Full Governing Body's committee structure enables us to manage these responsibilities.

Training is available for all governors and those new to being a governor are encouraged to attend induction training.

If you would like to stand for election, please complete the enclosed nomination form and return it to the school **not later than 9th February 2018**.

Nominations must be from parents with children at the school on the day that nominations close. Parents putting their names forward are invited to provide some brief biographical details limited to not more than 150 words suitable for inclusion in the ballot paper. Parents who have paid employment in the school for 500 hours per academic year or more or who are elected members of the Local Authority are not eligible to stand in this election.

The attached sheet summarises the qualifications to serve as a governor. Anyone standing for election must certify that he/she is not disqualified for any reason.

The successful candidate will be required to complete a Disclosure and Barring Service form regarding their suitability to have access to children and young people and will not be able to take up their appointment until clearance has been received.

If there are more nominations than vacancies the election will be by secret ballot. If that is necessary, voting papers will be sent to all parents together with details of the ballot procedure.

Eligibility Criteria

People who are ineligible to be a governor of an LA Maintained School:

A person who is under the age of 18 years

A person is disqualified from holding or from continuing to hold office as a governor or associate member if he or she:

- Is detained under the Mental Health Act 1983 during his or her period of office
- Fails to attend the governing body meetings without the consent of the governing body for a continuous period of six months, beginning with the date of the first meeting missed (not applicable to ex officio governors)
- Is subject to a bankruptcy restriction order or an interim order
- Has had his or her estate sequestrated and the sequestration order has not been discharged, annulled or reduced
- Is subject to:

 \diamond a disqualification order or disqualification undertaking under the Company Directors Act 1986

◊a disqualification order under Part 2 of the Companies (Northern Ireland) Order 1989

◊a disqualification undertaking accepted under the <u>Company Directors Disqualification (Northern Ire-</u> land) Order 2002

oan order made under Section 492(2)(b) of the Insolvency Act 1986 (failure to pay under a County Court administration order)

- Has been removed from the office of charity trustee or trustee for a charity by the Charity Commissioners or High Court on grounds of any misconduct or mismanagement, or under Section 34 of the <u>Charities and</u> <u>Trustees Investment (Scotland) Act 2005</u> from participating in the management or control of any body
- Is included in the list of people considered by the Secretary of State as unsuitable to work with children
- Is disqualified from working with children or subject to a direction under Section 142 of the Education Act 2002
- Is disqualified from registration for childminding or providing day care
- Is disqualified from registration under Part 3 of the <u>Childcare Act 2006</u>
- Has received a sentence of imprisonment (whether suspended or not) for a period of not less than three months (without the option of a fine) in the five years before becoming a governor or since becoming a governor
- Has received a prison sentence of two-and-a-half years or more in the 20 years before becoming a governor
- Has at any time received a prison sentence of five years or more
- Has been fined for causing a nuisance or disturbance on school premises during the five years prior to or since appointment or election as a governor
- Refuses to allow an application to the Criminal Records Bureau for a criminal records certificate

Please note that all governors in LA maintained schools must undergo a DBS (previously known as an enhanced CRB) check. A refusal to undergo this check will result in a non-appointment.
